# MEMORANDUM OF ASSOCIATION GRETEX INDUSTRIES LIMITED

- I. The name of the Company is GRETEX INDUSTRIES LIMITED
- II. The Registered Office of the Company will be situated in the State of West Bengal.
- 111. The Objects for which the Company is established are:

#### (A) THE MAIN OBJECTS\* OF THE COMPANY TO BE PURSUED ON ITS INCORPORATION ARE:

- 1. To carry on the business of buying, selling and dealing and manufacturing in all types of musical instruments, parts of musical instruments and to develop music education, training & teaching practices and to conduct cultural, educational programs to enhance the business and to deals in professional & domestic audio equipment's.
- 2. To carry on in India or elsewhere, the business of producers, processors, importers, exporters, distributors, agents, suppliers, hirers, renters, and dealers in all forms of audio-visual content including but not limited to radio/TV commercials, jingles, spots, films (including short films, ad films, corporate films, documentaries, and feature films), video films, web series, and video coverages; and to undertake activities such as transferring audio-visual content across various formats. To also trade, buy, sell, import, export, rent, lease, establish, procure, install, maintain, service, repair, and provide annual maintenance contracts (AMCs) for all types of equipment, instruments, apparatus, and appliances used in the production, post-production, exhibition, and broadcasting of audio-visual content, including but not limited to cameras, photographic equipment, projectors, LED televisions, display screens, video sets, audio-visual electronics, and other related electronic and electrical equipment, parts, and accessories. Further, to carry on the business of broadcasting, telecasting, relaying, transmitting, distributing, buying, selling, licensing, or running any news, films, audio, video, or any other programs over television, radio, internet, telecom networks, Over-The-Top (OTT) platforms, or any other existing or future electronic media, subject to necessary approvals, and to engage in all activities ancillary to the business of broadcasters of sound and/or audio-visual recordings and cable and wireless communications.
- 3. To carry on the business of a Non-Banking Financial Company (NBFC) as defined under the Reserve Bank of India Act, 1934, and to provide financing services, including granting of loans and advances, whether secured or unsecured, to individuals, firms, companies, or any other legal entities, and to engage in the business of hire purchase, leasing, factoring, bill discounting. microfinance, personal finance, business finance, consumer finance, and any other form of financing permissible under the regulations of the Reserve Bank of India (RBI).

# (B) OBJECTS INCIDENTAL ORANCILLIARY TO THE THEATTAINMENT OF THE MAIN OBJECTS:

- To purchase or otherwise acquire and hold on, invest, out of the surplus fund of the Company not immediately required, trade, deal in, mortgage, pledge, assign, sell, transfer or otherwise dispose of any goods, wares, merchandise and all movable property for carrying out the business of the Company.
- 2. - 7. To enter any arrangements with any Governments or any authority, supreme, municipal, local or otherwise that may seem beneficial to any of the Company's objects and to apply for, promote and obtain by any Act of any legislature, charter, rights, powers, privileges, concessions, grants, decrees, provisional orders, licences or authorizations of Government-Central or State, or any relevant authorities (local or otherwise) or any private party for enabling the Company to carry any of its objects into effect or for any purpose which may seem expedient and to oppose any proceedings or applications which may seem calculated to prejudice the interests of the Company.

- 9. To enter into arrangements with companies, firms and persons for promoting and increasing the manufacture, sale, purchase and maintenance of goods, articles or commodities of all and every kind and descriptions, either by buying, selling or assisting such other companies, firms or persons

- 10. To advance out of the surplus fund of the Company not immediately required, securities and property with or without security as may be thought proper, to such persons, companies, corporations or firms and on such terms as may seem expedient and in particular to customers and others having dealings with the Company and to release or discharge any debt or obligation owing to the Company.
- 11. Subject to the provisions of the Companies Act, 1956 to receive money on loan and borrow any money in such manner and with or without allowance of interest thereupon as the Company shall deem fit and to secure the repayment of any money borrowed, raised, received or owing by mortgage, pledge, charge or lien upon all or any of the property or assets of the Company (both present and future) and also by similar mortgage, charge, pledge or lien to secure the guarantee the performance by the Company or any other person, Company, firm or body Corporate of any obligation undertaken by the Company or any other person, Company, firm or body corporate as the case may be, and to give the lenders or creditors the powers of sale and other powers as may seem expedient, provided however, that the Company shall not do any banking business as defined in Banking Regulations Act, 1949 and money circulation business or Chit-Fund activities.

- 19. To pay out of the funds of the company all costs, charges, and expenses which the Company may lawfully pay with respect to the promotion, formation and registration of or for the business of the company and/or the issue of its capital or which the Company shall consider to be necessary including therein the cost of advertising, printing and stationery and commission for obtaining the underwriting of shares, debentures or other securities of the Company.
- 21. 
